Approval of October 21, 2015 minutes deferred until December 16th meeting.

Treasurer and financial reports. Presented by Laury Scott, Treasurer with comments from Director Nakakura.

- 1. Action Scott moved, Leanio second to accept financials as presented. Passed unanimously.
- 2. Nakakura clarified that the vans were purchased with USDA loan and may not be shown on the Balance Sheet. When reflected in the balance, the amount will count as cash on hand. The regular checking account cannot count as cash on hand but operating funds can. WHEA needs to maintain \$300,000 in order to meet the cash in hand requirement. The extra \$12,400 for the two students beyond the 280 projected enrollment is a buffer.
- 3. Discussion/Action Treasurer recommendations:

- One of the WHEA accounts only requires one signature. Scott moved, Buchanan second that we will have two authorized two signers on each account.
- Scott moved, Edwards second that we keep approximately \$250,000 in any one bank at a time so that the funds are covered by FDIC.
- Nakakura suggested that we pay our rent to the Foundation in a lump sum at the
 beginning of the year. A benefit is that there will be one less account with
 which to deal. This also would support the Foundation and make it more
 viable. The auditors have raised a question about the viability of the
 Foundation so this cash up front would be helpful to demonstrate viability.
 Nakakura clarified that the Commission must dispense the money in July
 and November. Scott will check with the auditor to see if this would be
 considered acceptable.
- Scott reported that it is unclear whether the GB should purchase additional insurance. Errors & Omissions and General Liability are covered by the state. There is no recommendation at this time because price quotes have not arrived.
- 4. Exploration Foundation update: The president of the Foundation has threatened to resign. Can the members of the Foundation board members be given special consideration in the WHEA admission process? Nakakura clarified that this is not allowed at this time and would require a waiver from the Commission.

The Foundation board recommended that applications for the WHEA GB serve on the Foundation before joining the GB.

There are several ways to give to the Foundation. People can now give through PayPal. In the future, maybe WHEA should publicize Foundation in letters that are sent home to parents or a letter from the Foundation could be included with report cards. Families can't afford to give might be asked to donate time. They could make phone calls soliciting donations. WHEA staff representatives pointed out that care should be taken not to solicit gifts from the same donators that support the Hoolaulea and Community Fair. Leanio will compile a list and share it with the Foundation. Who had application to become a member of the GB. The next Foundation meeting will be January 13th here at WHEA Campus. Pawasarat-

Losalio will contact the prospective GB members to see if they are interested in serving on the Foundation Board.

- & 4 Director Evaluation: The Governance Committee will create a director description and bring it to the next meeting as the first step in Director Evaluation.
- 2. Board member applications: invite to committees
- 3. Dress Code: The GB at an earlier meeting decided that the WHEA office would no longer provide shirts for students who don't dress appropriately. However, last month the teacher rep presented the decision in a staff meeting and was told that the teachers didn't agree with that decision. The dress code is only effective if the staff buy in and consistently apply the code. Shellese or Heather will go up to the student and logs the behavior. Who will call the parent? Office staff or student? No decision was needed as staff will follow the dress code policy.

Pawasarat-Losalio will follow up with the Commission and find out how much time they need and attempt to include them on the agenda on Jan 20. December meeting retreat?
- 7. The GB meeting on December 16th will be devoted as much as possible to relationship building on the GB. Pawasarat-Losalio will appoint one GB member to find an informal off campus place for the board to meet.

Nakakura redirected her to Ms. Burns and her teachers to discuss the issue.
